## **Repertoire Requirements: (PLEASE NOTE REVISIONS)**

**Junior Division:** Contestants who are 12 or under are required to play one of the following:

Two-Part Inventions: No. 2 in C minor, No. 7 in E minor or No. 9 in F minor AND a different Two-Part Invention of the contestant's choice.

**Intermediate Division:** Contestants who are 17 or younger are required to play one of the following

Sinfonias: No. 7 in E minor, No. 9 in F minor or No. 11 in G minor AND a different Sinfonia of the contestant's choice.

**Senior Division:** Contestants who are 20 or younger are required to play one of the following:

Preludes and Fugues from the *Well-Tempered Clavier*, Volume I: No. 4 in C-sharp minor, No. 8 in E-flat minor or No. 22 in B-flat minor AND a Prelude and Fugue of the contestant's choice from the *Well-Tempered Clavier*, Volume II.

All repertoire must be performed from memory.

**Special Rules:** This is a "blind" competition. The judges cannot see the contestants and the contestants cannot see the judges. However, all members of the audience can see both the contestants and the judges.
