PRESIDENT'S MESSAGE

Greetings!

As we watch the colors of autumn turn we know that music lessons are in full swing! Promote the fall colors to inspire your students to develop a wider palette of sound which, in turn, can enhance performances. Encourage students to strive for more dynamic variety to help them express their music and sustain the learning experience so that the music continues to interest them. As teachers we should stress the musical qualities of playing an instrument. While students are busy learning new pieces, demonstrate for them so that they can feel your love and understanding of the music. They can also observe the physical movements necessary to produce the desired effects while honing their listening skills. Other pedagogical goals can include instilling proper practicing skills, mastering proper bowing techniques, exploring a deeper depth of musical perception, revealing efficient ways to memorize, and, if involved in piano studies, experimenting with pedaling and colors. Performing repertoire will be infinitely more satisfying if the performer feels a connection to the music. You, the teacher, can facilitate this process.

I would like to inform you of the Washington Music Teachers Association 2009-2010 Gretchen Hood Strings Competition, generously sponsored by Potters Violin Shop. It will take place on Saturday, December 19, 2009 at the Women's Club of Arlington. The categories are Junior HS (Grades 7-9) and Senior HS (Grades 10-12). There will be a First and Second place in each category with cash awards generously sponsored by Dalton Potter of Potters Violins in Bethesda.

Teachers do NOT need to be members of WMTA, however the application fee of \$22/27 is doubled for non-members. If you already are a member of MTNA, membership in WMTA is only \$30 for the year.
